# The Green Amendment - The People's Fight For a Clean, Safe & Healthy Environment, including Climate

As the impacts of climate change manifest worldwide, and environmental degradation continues to rise and devastate the health and safety of communities, activists must acquire new tools for environmental protection – it is increasingly clear that we can no longer rely on federal and state legislation to fight for a cleaner environment. The sad truth is that our laws are designed to accommodate pollution rather than prevent it. As a result people feel powerless, and communities of color, low income communities, and communities with high immigrant populations continue to be disproportionately targeted for placement and expansion of polluting industrial operations. But there is a solution: bypass the laws and turn to the ultimate authority—our state and federal constitutions.

This talk will seek to engage and inspire pursuit and use of a new tool for environmental protection – constitutional recognition of environmental rights. With constitutional recognition of an inalienable right to a healthy environment we will empower people with new advocacy and legal tools, level the playing field, and provide real hope for communities everywhere fighting for clean and healthy environments, including providing particularly powerful new arguments for environmental justice communities and protection of future generations. In this session, author of the best selling new release titled The Green Amendment, Maya van Rossum will talk about:

- how legislative environmentalism has failed communities
- the transformational difference environmental constitutionalism can make, including for protection of future generations and environmental justice communities that continue to be disproportionately targeted for polluting projects
- how people can take action in their communities to secure a Green Amendment, or if they live in one of
  the three states that already has this protection, the talk will focus on how to use the constitutional
  entitlement to full and best effect.
